Earlier this month, the Centers for Medicare & Medicaid Services (CMS) published an [Interim Final Rule](#) on COVID-19 Vaccine Requirements. This rule applies to residents, clients, and staff of Skilled Nursing Facilities (SNF) and Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICFs-IID).
