## **HEALTH ADVISORY: COVID-19 Vaccine Boosters Recommended for All Adults**

Guidance from the Centers for Disease Control and Prevention (CDC) regarding COVID-19 vaccinations and boosters is quickly evolving. Below is a high-level summary of the most current recommendations. - COVID-19 booster doses are now recommended for all adults ages 18 years and older at least 6 months after completion of an mRNA primary series (Pfizer-BioNTech or Moderna) or at least 2 months after completion of a one-dose Janssen primary series as follows:
  - Pfizer-BioNTech 30 μg as 0.3 ml dose (same as the primary series dose).
  - O Moderna 50 μg as 0.25 ml dose (half of the dose used for the primary series).
  - o Janssen 5×10<sup>10</sup> viral particles as 0.5 ml dose (same as the primary series dose).
- Heterologous (mix-and-match) booster doses can be administered for any of the COVID-19 vaccines authorized or approved by the U.S. Food and Drug Administration (FDA). Heterologous dosing may be considered for the booster dose only; all doses in the primary series should be completed with the same vaccine product.
  - When using a heterologous booster dose, the interval is determined by the vaccine received for the primary series.
- Adults age 18 years and older who received a complete primary series of a COVID-19 vaccine that is listed for emergency use by the World Health Organization (WHO) but neither authorized nor approved by the FDA should receive a booster dose of Pfizer-BioNTech COVID-19 vaccine at least 6 months after completing their primary series. As of December 2, 2021, the WHO lists the following COVID-19 vaccines for emergency use:
  - o Pfizer-BioNTech COVID-19 vaccines (e.g., COMIRNATY, Tozinameran)\*
  - Janssen (Johnson & Johnson) COVID-19 vaccine\*
  - Moderna COVID-19 vaccine\*
  - o AstraZeneca-Oxford COVID-19 vaccines (e.g., Covishield, Vaxzevria)
  - o Sinopharm Beijing Institute of Biological Products (BIBP) COVID-19 vaccine
  - o Sinovac-Coronavac COVID-19 vaccine
  - o Bharat Biotech BBV152 COVID-19 Vaccine (COVAXIN)
  - \* Also authorized by the FDA

- The NYSDOH strongly encourages healthcare providers who do not already offer COVID-19 vaccine to their patients to enroll in the COVID-19 vaccine program.
