SESSION: Employment & Labor Law Update: Addressing Critical Workplace Issues Before It's Too Late

SUMMARY: With the avalanche of laws and regulations being issued and amended these days, its easy to lose track of key changes that need to be addressed in the workplace. During this program, we will examine important developments in employee paid and unpaid leave laws, handling of various forms of pay incentives unique to long-term care operations, best practices to avoid discrimination claims, as well as an update on significant labor law developments.

SESSION: Safeguard Your Bottom Line: Protect Your Facility with Your Admissions Agreement

SUMMARY: Health Care Facility owners, CFOs and staff often believe Admission Agreements adequately protect the facility from a Medicaid, Medicare and collections standpoint. However, when a resident fails to pay their private pay balance, NAMI, co-pays, penalty periods before Medicaid begins, etc., the facility may find out that their Admission Agreement doesn't offer the necessary protection to pursue their right to payment against a resident or a third-party signatory to the Admission Agreement. This expensive lesson can be avoided by ensuring your facility's Admission Agreement includes all the essential components required to recoup payment and preserve your bottom line.

The best defense is an offense. Our awardwinning attorneys will provide the background knowledge you need and tips to take back to your facility to implement immediately, including:

OBJECTIVES:

- The major obligations of a third-party signatory, including the difference between personal liability for damages vs. a third-party guarantee of payment;
- Addressing Medicare/Medicaid/ third party insurance coverage in an Admission Agreement;
- Crafting your Admission Agreement to allow "red flags" such as asset transfers and Medicaid non-eligibility issues to be revealed at or before the admission of a potential resident;

- Ensuring your Admission Agreement provides full compensation for collection actions, including late charges, collections costs, interest and attorneys' fees available to the facility in the event of nonpayment; and
- Other important aspects of Admission Agreements that can be important in the event of future litigation.

SESSION: Multigenerational Management

SUMMARY: Modern day workplace has four generations working under one roof. SESSION: When a Carrot is Really a Stick: CMS SNF VBP

SUMMARY: The SNF Value-Based Purchasing (SNF VBP) Program was established in 2014 as required by the Secretary of Health and Human Services. Under the program, 2% of SNF FFS Medicare Part A payments are withheld and 60% are redistributed to SNFs as incentive payments for performance. This session will focus on how to monitor facility performance and best practices to be on the receiving end of incentive payments.

OBJECTIVES:

Describe the SNF VBP Program and identify what data is used to calculate the SNF 30-Day All-Cause Readmission Measure (SNFRM; NQF #2510).

- Outline the steps to monitor individual facility performance.
- Define how the suppression policy in the FY 2022 SNF Final Rule affects the SNF VBP Program.
- Identify potential causes and plan best practices to prevent hospital readmissions following SNF discharge.

SESSION: Long Term Care Regulatory and Legal Update

SUMMARY: New York's health care administrators are facing a number of legal, legislative and regulatory issues that could directly impact their ability to deliver high quality, cost effective long term care throughout the State. This session will shed light on the key legal, legislative and regulatory issues facing providers and examine their practical operational implications as well as their impact on the delivery of care.

- Identify and mitigate DEI related organizational policies and processes that are at risk

SESSION: Staying Informed: An Update on Reimbursement and other Nursing Home Matters

SUMMARY: Nursing homes continue to face an increasingly complex operating environment driven by COVID, transformations in reimbursement, expense increases and increased regulatory oversight. Without a proper understanding of the current environment, providers risk reduced reimbursement, lower margins, and regulatory backlash. This session will include a detailed discussion of recent changes to the Nursing Home operating environment, including Medicaid reimbursement, minimum staffing requirements, and the "70/40/5" rules. The session will also discuss several operating challenges, how each challenge is measured quantitatively and qualitatively, and the strategies to avoid hitting operating pitfalls.

SESSION: Psychotropics, Pharmacy Survey Trends, COVID Treatment Updates and More!

SUMMARY: In this session, Dr. Hallett will review the latest survey trends in Pharmacy to help you be ready for your next survey. Covered topics will include unnecessary drugs, handling/dating of insulin pens and other med storage issues, and of course a review of findings related to psychotropics and more. Additionally, Dr. Hallett will provide the latest information on COVID treatment protocols and what we might expect as we make our way into Summer and Fall of 2022.

SESSION: Managing Managed Care

SUMMARY: Managed Care Plans, also referred to as HMOs or PPOs, include equivalent coverage to traditional Medicare Part A and Part B, and tout additional benefits like routine vision, hearing and dental services and prescription drug coverage. Plans have become increasingly desirable due to these added benefits and CMS encourages beneficiaries to enroll in Managed Care plans. Currently, Managed Care has consumed 30% of the Medicare population and is anticipated to grow exponentially through 2030.

With this increase of enrolled beneficiaries, Managed Care insurers continue to find new reasons to deny payments to long-term care providers. Managed Care plan administrators must agree the beneficiary's treatment is medically necessary, or they may deny approval for service. Further, HMO plans have limited appeal rights. Skilled nursing facilities are seeing reduced reimbursement yearover-year with commercial insurers managing Medicare and Medicaid programs.

This session will provide key strategies to manage Managed Care. Attendees will examine the differences between Managed Care and Medicare. The presenter will discuss elements to address managed care plans that can be incorporated into your pre-admission screening process. Learn how to develop a system for Case Management for SNF providers. Participants will explore common Managed Care billing challenges.

Learn how to fight the good fight! Gain insight of where to verify reasons for payment denial, how to identify regulatory language to assist in disputing denials and how to fight claims through CMS.

SESSION: The Role of Ethics Codes as a Catalyst for Improving Practice

SUMMARY: At the foundation of every quality senior community is a strong awareness and practice of ethical organizational standards. As a leader, in long term care, issues arise frequently that require you and your team to address them in a responsible and ethical manner. Ethical discussions, while sometimes very difficult to work through, impact major life issues that have long term consequences. In today's world this reality is more prevalent than ever. This workshop will contain a combination of lecturette, case studies and team interaction. Emphasis will be on the areas of administrator, social work and dietary. **LEARNING OUTCOMES:** Following this program, participants will be able to:

- Understand and use an ethical decisionmaking framework.
- Appreciate the ethical standards of other professions.
- Possess a higher understanding of the array of ethical issues that may arise.
- Engage in difficult discussions, using enhanced listening and reflection.
