

HRSA Begins Provider Relief Fund Repayment Notification

Health Resources and Services Administration began transmitting emails to providers who, based on Provider Relief Fund Reporting Period 1 submissions, will be receiving a Repayment Request Notice via the U.S. Postal Service. In guidance to AHCA/NCAL, HRSA noted initial notification will come in the form of an alert email to the PRF listed contact(s). The email will not contain the payment specific information included in the Repayment Request Notice.

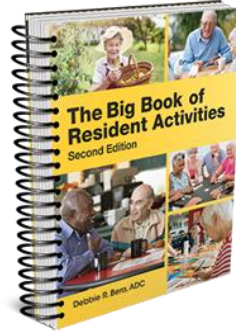
