

[HHS Extends Public Health Emergency Through April 11](#)

U.S. Health and Human Services Secretary Xavier Becerra today renewed the declaration that a public health emergency (PHE) exists. This is effective January 11, 2023, and will continue for 90 days pursuant to federal law. The PHE renewal through mid-April provides for the uninterrupted continuation of several flexibilities that have protected beneficiary access to important services in as safe and effective manner as possible.
