**Soliciting Feedback on a Proposed Regulatory Framework to Assess the Risk to the Effectiveness of Human and Animal Drugs Posed by Certain Antibacterial or Antifungal Pesticides** — On September 26, a concept note was published that describes a proposed framework to improve assessment of the potential risks to the effectiveness of human and animal antibacterial and antifungal drugs posed by using certain antimicrobial pesticides. The concept note was developed through a U.S. government interagency process by the U.S. Environmental Protection Agency (EPA), the U.S. Department of Health and Human Services (HHS), and the U.S. Department of Agriculture (USDA), under the oversight of the White House Executive Office of the President. This concept note solicits stakeholder input on the proposed structure for the framework and on potential solutions, research, or mitigation approaches to reduce the spread of antimicrobial resistance (AR). The proposed framework described in the concept note would expand the current EPA process for assessing the risk that antibacterial or antifungal pesticides may pose to the effectiveness of human and animal antibacterial and antifungal drugs when EPA evaluates pesticides under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA). The comment period is open until November 13, 2023, and information on how to provide comments is available from EPA [here](#).

**Coming soon: V-safe for RSV vaccines** — [V-safe](#), one of [several systems](#) CDC uses to closely monitor the safety of vaccines, will be available this fall to include health check-ins initially for adults 60 years and older who receive a [respiratory syncytial virus](#) (RSV) vaccine and soon thereafter for pregnant people who receive a maternal RSV vaccine.

V-safe, originally developed in 2020 for people to report how they felt after receiving COVID-19 vaccines, will enable participants to report how they feel after getting an RSV vaccine. Additionally, enhanced functionality will allow participants to use a computer, smartphone, or tablet to enroll and complete health check-ins.

After receiving an RSV vaccine, participants can enroll in V-safe to receive health check-ins via text messages or emails to complete confidential surveys so that they can quickly and easily share with CDC how they feel after getting vaccinated (for example, if they are experiencing injection site pain or a fever). The data collected through V-safe help CDC monitor potential vaccine side effects and inform the public about what to expect following vaccination.

## **NHSN Nursing Home Reporting Changes for New “Up to Date” COVID-19 Vaccination**

**CDC Recommends Updated COVID-19 Vaccine for Fall/Winter Virus Season** — CDC’s Advisory Committee on Immunization Practices (ACIP) met on September 12 to vote on recommendations for the updated COVID-19 vaccines. CDC recommends everyone 6 months and older get an updated COVID-19 vaccine to protect against the potentially serious outcomes of COVID-19 illness this fall and winter.

Vaccination remains protective against the most severe illness and death caused by COVID-19, including against the XBB sublineages, which account for over 95% of the circulating virus variants in the U.S. COVID-19 vaccines also reduce the chance of having Long COVID. An important goal of vaccination is to broaden immunity, even if vaccine formulations do not perfectly match currently circulating viruses.

While there are many factors that affect the exact dates of when vaccines arrive to the public, the updated COVID-19 vaccine will be available in the United States in the coming days, providing an opportunity to get increased protection heading into the fall and winter months, when we expect transmission to be higher. Vaccines will be widely available at many healthcare providers, including pharmacies. The Disability Information and Access Line (DIAL) also provides COVID-19 vaccination support for people with disabilities. You can access DIAL by calling 1-888-677-1199.

Given the possibility of a surge of COVID-19 cases this fall and winter, we encourage providers to talk with their patients about getting the updated COVID-19 vaccine as this new vaccine more closely targets the most common variants circulating now.

## October 6<sup>th</sup>: New High-Risk Misinformation Alert

Last week, a high-profile social media CEO shared a misleading video showing a decline in the reported effectiveness of COVID-19 vaccines over time—insinuating that early headlines about the vaccines being “100 percent effective” were disinformation. The video, viewed over 75 million times, doesn't distinguish between trial efficacy and real-world effectiveness, or between effectiveness against severe disease and effectiveness against infection.

Developed through automated media monitoring and manual review by public health data analysts at [The Public Good Projects](#), our misinformation alerts are categorized as low, medium, or high risk to

help you identify the next appropriate action. [The COVID-19 vaccine misinformation alert outlined above](#) is considered high risk, and we recommend using our messaging to directly address and debunk this type of misinformation.

### **September 15<sup>th</sup>: Updated COVID-19, RSV, and Flu Recommendations**

On Tuesday, September 12, the CDC released [updated COVID-19 vaccine recommendations](#) for the fall and winter respiratory illness season. The CDC Advisory Committee on Immunization Practices (ACIP) recommends updated (monovalent, XBB-containing) COVID-19 vaccines for everyone age 6 months and older

**Pfizer-BioNTech and Moderna will continue to distribute doses across the country, but vaccines are already available in many communities.** The updated vaccines were created to more closely target the new strains of coronavirus that are currently circulating. These vaccines significantly reduce the risk of developing severe COVID-19 complications and hospitalization and protect against avoidable severe illness or death.

## United States Fire Administration (USFA)

### Open Enrollment Changing from Twice a year to Quarterly.

The U.S. Fire Administration's National Fire Academy (NFA) is moving away from the twice a year enrollment periods for students to apply for courses at the National Emergency Training Center. This decision was made after receiving student and stakeholder feedback.

The NFA will be switching from a twice-yearly open enrollment to a quarterly open enrollment. Please note, this change does not affect the enrollment processes of the Executive Fire Officer Program (EFO) or Managing Officer Program (MOP). These programs have a separate enrollment process, information can be found here (<https://www.usfa.fema.gov/nfa/programs/>). The open enrollment period will be open for 30 days and will be for a 3-month period.

Open Enrollment will be as follows:

#### Open Enrollment period:

December 15 - January 15

March 15 – April 15

June 15 – July 15

September 15 – October 15

#### For the months of:

April, May, and June, 2024

July, August, and September, 2024

October, November, and December, 2024

January, February, and March, 2025

This open enrollment change could potentially allow a student to apply and attend a class within a 6-month window. The new open enrolment process does not affect the limit of one student stipend per fiscal year (10/1 to 9/30) (<https://www.usfa.fema.gov/nfa/on-campus-students/travel-reimbursement/>). Questions? The maximum size for each PDF is 1 MB. If you do not know how to prepare a PDF document please seek information technology (IT) support.
  - **IS-29: Public Information Officer Awareness is a pre-requisite. Please complete prior to applying for Public Information Basic - EMI - IS (fema.gov)**
- All EMI and NFA applications require an electronic approval from the head of your sponsoring organization. You will need the name, title, and email address of this person to submit the application. Non-Federal applicants for EMI courses must use the appropriate State Training Officer (STO) as “Head of Organization”.
